

Cookie Policy

MIZARSTVO ŠPORAR JANEZ S.P., Obrh 3, 8350 Dolenjske Toplice, Slovenia, Europe (hereinafter: “**the company,**” “**we,**” “**us,**” or “**our**”) is the owner and provider of <https://sporar.org/> and its various sub-domains (hereinafter collectively referred to as: **the website** or **site**), in connection with which it processes certain website visitor information and personal data as a controller of personal data. One of the ways we do this is through the use of "cookie" technology, whereby small text files are stored on the visitor's computer. We use cookies only to read the information that was stored on your hard drive by the cookie that was placed in connection with our website or our partners websites, with the exact list of such cookies and their function given below.

1. General information about cookies

1.1. What are cookies?

“Cookies” are a technology used by modern websites to collect and store certain settings and technical information of the website visitor, with which it is possible to identify certain characteristics of an individual visitor. This information reveals, among other things, when and how visitors use the website and allows the company to continually improve its site. The use of cookies is a common and widespread practice of many modern websites.

The company can also use its own cookies and the cookies of its advertising partners to advertise its products and services to relevant visitors elsewhere on the Internet (i.e. not just on its own website), whereby the company does this only when granted the consent of an individual visitor to install **optional cookies** that are provided to the company by its advertising partners.

Agreeing to the installation of cookies can also offer you certain advantages as a visitor, such as saving your settings, filling out various forms with pre-prepared entries, better adaptation of the website to your device or your needs, etc.

2. Your permission to install cookies

When visiting our website a pop-up window shall notify you that with the exception of the installation of our **mandatory cookies, that are required for the normal operation of the website** (e.g. cookies for saving your settings, adjusting the display dimensions of the website to your device, etc.):

- installing **optional cookies** is only done after obtaining the visitors **express consent** (**clicking on the "load optional cookies" button** when visiting the website for the first time) and,
- is under the visitors **complete control**, since the visitor may also configure his browser in order to **restrict or disable the storage of cookies**,
- whereby the installed cookies can also be **removed at any time**, in accordance with the instructions below.

Do not click the buttons for installing individual types of cookies when visiting our website if you do not want cookies to be installed on your device when visiting our website. Should you

wish to remove the cookies that might have been installed previously, please follow the procedure laid down below.

Removal or blocking of cookies may result in suboptimal operation of this website.

4. Descriptions of individual services offered by our advertising partners

Google Analytics

Google Analytics is a web analytics service provided by Google Incorporated, 1600 Amphitheater Parkway, Mountain View, CA 94043, USA ("Google"). The aforementioned service collects and stores data on our website for the purposes of creating usage profiles that are pseudonymized. These usage profiles are used to analyse visitor behaviour and are evaluated to improve and tailor the offer. Information for this purpose is obtained by our advertising partner, Google, which is also the provider of the cookies in question, including information about the time, location and frequency of visits to our website and the abbreviated IP address of the visitor. The following information is automatically sent to Google in the United States, whereby Google also stores it in accordance with its privacy policy, which can be accessed here: <https://policies.google.com/technologies/ads?hl=en-US>

In this case, the IP address of visitors from within member states of the European Union or in other contracting states of the Agreement on the European Economic Area is already being shortened by Google and thus being anonymised. Google may transfer this information to third parties if required by law or if third parties process this data on behalf of Google. However, Google does not claim to associate the IP address with any other data obtained by Google. The installation of the relevant cookies can be disabled by selecting the option to disagree with the installation of this type of cookie, when you are asked to offer your consent to analytical and other optional cookies. In this case, the site may not be fully functional for your use. The pseudonymised user profiles will not be merged with personal data about the bearer of the pseudonym without his explicit consent. Google Analytics for Remarketing

The Google Analytics tracking code implemented on this site has been enhanced with Remarketing for Google Display Advertising, a service that analyses user behaviour across the Google Display Network. Conversion measurement with Facebook Pixel

With your consent, we use the "visitor action pixel" which is provided to us by Facebook Inc. 1601 S. California Ave, Palo Alto, CA 94304, USA ("Facebook") on our website. In this way, the behaviour of users can be tracked after they have been redirected to our website by clicking on a Facebook ad. This process is designed to evaluate the effectiveness of Facebook advertisements for statistical and market research purposes and may help optimise future advertising efforts. The data collected are anonymous to us and as such do not provide us with any conclusions about the identity of the users. It may then also be stored for these purposes as a cookie on your computer. Regarding the use of the visitor action pixel, consent may only be given by users who are older than 13 years of age.

If you are younger, we request that you ask your legal guardians for permission. If you do not wish for us to record your use of our offers through Facebook, you can prevent this by setting your browser settings accordingly.
